**ALL ELIGIBLE JUNIOR/SENIOR STUDENTS  
OF M.A./M.Phil/Ph.D. PROGRAMMES**  
(Mumbai and Tuljapur Campus)

**[ GOI-POST MATRIC SCHOLARSHIP SCHEME ]**

This is to bring to the notice of all students (SC/ST) who have claimed fees exemption that they are mandatorily required to submit the Government of India Post-Matric Scholarship Scheme Application Forms (on-line/hard copy) at the earliest along with all necessary documents. The list of documents required to be submitted are displayed on the Notice Board of Social Protection Office (SPO). Kindly note that the application forms of GOI-PMS (on-line/hard copy) are to be submitted **every year** (Fresh application by juniors and Renewal application by seniors).

It is the individual, eligible student's responsibility to fill and submit the online/offline application form of GOI-PMS for the Academic Year 2017-18 within the specific time frame announced by the concerned authority of the respective State Government. Students failing to fill the application forms for any reason by the prescribed due date will be considered as not being interested to be considered for GOI-PMS and the entire exempted fees, including Dining Hall/Hostel Charges and advances, if any, will be recovered in full by the Institute. The release of the grades/degrees shall be subject to payment of all fees in such cases.

**(A) STUDENTS FROM OTHER STATES [SC/ST/OBC(NC)]**

The State Governments will announce the details of the scheme and invite applications during the period from June to August, 2017. The eligible SC/ST/OBC(NC) students should fill and submit the online/offline application form within the date specified by the respective State Governments. It is the responsibility of the individual eligible student to complete and submit the application forms.

Wherever the State Government/Authority Concerned have indicated that the GOI-PMS application form (hard copy/on-line) will be issued/accessed after 31 August, 2017, the students are required to submit an application indicating the tentative date of submission of GOI-PMS application form to the Social Protection Office.


**(B) SC STUDENTS FROM MAHARASHTRA STATE**

The SC students from Maharashtra who are applying for PMS should first apply on-line for Scholarship through the website of Department of Social Justice, Special Assistance <http://mahaeschol.maharashtra.gov.in> before the due date and submit the hard copy of scholarship application alongwith photo copies of required documents (duly attested).

The SC students (Juniors) who have joined in this academic year 2017-18 should open their bank account in Corporation Bank, Chembur Branch, Tolaram Shopping Centre, N.G. Acharya Marg, Near Adarsh Hotel, Chembur, Mumbai 400 071 before filling the on-line application form.

**(C) ST STUDENTS FROM MAHARASHTRA STATE**

The ST students from Maharashtra who are applying for PMS should first apply on-line for Scholarship through the website of Department of Tribal Affairs, Special Assistance <http://e-tirbal.maharashtra.gov.in> before the due date and submit the hard copy of scholarship application alongwith photo copies of required documents (duly attested). The ST students (Juniors) who have joined in the academic year 2016-17 should open their bank account in State Bank of India, Deonar Branch, Deonar, Mumbai 400 088 before filling the on-line application forms.

**Opening of Savings Bank Account (only for students from Maharashtra):**

The purpose of opening the savings bank account is that the Social Welfare Office and Tribal Affairs Office, Maharashtra State will remit the Scholarship Maintenance Allowance of the GOI-PMS eligible students directly to their respective saving bank accounts.

The documents to be submitted along with the application form of opening bank account are:

1. Photocopy of College Identity Card.
2. Address Proof (any one of the below mentioned documents).
  - a. Bonafide Certificate for Address Proof.
  - b. Aadhar Card
  - c. Electricity Bill (if, in the name of parents, then signature of parents on the same)
  - d. Driving License
  - e. Passport
  - f. Voter Identity Card


The students will be required to produce a copy of their bank pass book to inform the Social Protection Office of receipt of scholarships for adjustment of fees due.

**Procedure for Submission:**

**Offline/Hardcopy:** All the eligible SC/ST/OBC(NC) students (other than Maharashtra State) have to approach/contact your District Welfare Office and request for GOI-PMS application form for the Academic Year 2017-18 (fresh/renewal). While collecting the blank application form, please confirm the address of the authority concerned with name of officer and designation, list of required documents to be attached with application, last date of submission, etc. Please fill the application form properly, completely and attach all the required attested documents (three sets), and submit to the Social Protection Office well in advance and in any case 15 days before of the due date declared by the respective State Governments.

**Online:** All the eligible SC/ST/OBC(NC) students (other than Maharashtra State) have to visit the website of your District Welfare Office through desktop/laptop. Register yourself through login (if fresh) or use your last year login name & password (if renewal). Fill the online application form and upload the necessary documents, and take two printouts of the application. One printout is to be kept with you for your information and the other printout with all the required attested documents (three sets) have to be submitted to the Social Protection Office well in advance and in any case 15 days before the due date declared by the respective State Government. While submitting the application to SPO, TISS, please provide the detailed address of your District Social Welfare Office.
