

Plan of Action for GoI PMS Students

A. It is already notified that for SC/ST students eligible for GoI PMS registered to be admitted for Masters programme 2018-20

1. Candidates from Scheduled Caste and Scheduled Tribe who are eligible for Government of India's Post Matric Scholarship are exempted from payment of course fees.
2. At the time of admission, they are required to pay (a) the base fee of Rs 4500/- (towards caution deposit, student union fee and medical insurance fee) and (b) hostel charges of Rs.15000 for the semester. The Dining Hall charges shall be payable at actuals on monthly basis.
3. OBC (NC) candidates who are eligible for GOI-PMS shall pay (a) all the prescribed course fees for the programme to which they are admitted and (b) hostel charges of Rs.15000 for the semester. The Dining Hall charges shall be payable at actuals on monthly basis.
4. OBC (NC) candidates eligible for GoI PMS can additionally avail the upfront scholarship of Rs. 12,000 at the time of admission.

B. Proposed Measures to address the concerns raised subject to calling off the agitation

For SC/ST students eligible for GoI PMS registered for Masters programme in the year 2016-18

5. As proposed in the meeting of Students' Delegation with the team of Administration on 22 nd February 2018 7:45 to 10.45 pm at the office of the Director, the hostel charges shall be waived off.
6. The payment of Dining Hall charges are being deferred until the time that the student has the means to do so (as and when they receive the scholarship amount from the government in their accounts or when they get employed)
7. The above students will be permitted to continue with their studies and appear for exams in March-April, 2018 irrespective of the status of payment of Dining Hall or Hostel Charges.

For SC/ST students eligible for GoI PMS registered for Masters programme in the year 2017-19

8. Hostel Charges for the first year (2017-18) are proposed to be waived off with the belief /understanding that the necessary resources shall be mobilised.
9. Dining Hall charges for the first year shall be payable at actuals on monthly basis.
10. Hostel Charges for the second year (2018-19) shall have to be paid by the students.
11. Dining Hall charges for the second year shall be payable at actuals on monthly basis.
12. Efforts shall be made to generate resources to reduce the burden for students in paying the Hostel and Dining Hall Charges as the case may be.

C. General

13. Funds to meet the support for Hostel and Dining Hall Charges mentioned in items above will be generated by a Joint Scholarship Committee comprising members from administration, faculty and students. This committee will continue to work for generating resources for the upcoming batches.
14. A programme officer will be appointed within two months to look into the issues related to scholarship matters and liaise with the state governments and central government departments.
