As per the acknowledgement produced, the copies of the draft notice of motion are served to the advocates for the defendants.

Ld. Counsel for plaintiff has submitted that despite order dated 28.3.2018 passed by this court, the defendants are not holding peaceful demonstration and they are actively obstructing the daily activities of the management and college, including residents of the campus. He has filed draft notice of motion praying for other interim reliefs. He has also filed further affidavit in support of the earlier notice of motion and documents in support of the notice of motion.

The earlier order shows that matter was adjourned for filing reply to the notice of motion by the defendants. However, today there is no appearance on behalf of defendants, and thus reply not has been filed. Ld. Counsel for plaintiff has made a statement that writ of summons is also served on all defendants.

I have perused the further affidavit filed by the plaintiff in support of the notice of motion. In view of the serious allegations made in the affidavit, by way of ad-interim relief, the defendant no.1- Association is restrained from making any demonstrations within 100 meters from the main gate of the campus.

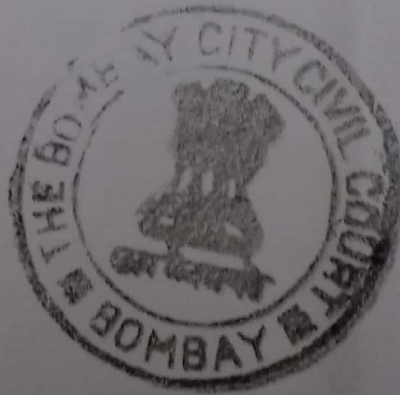
Adv. Ms. Afri for D-1 has also appeared now and seeks time to file composite reply to the notice of motion and the earlier notice of motion.

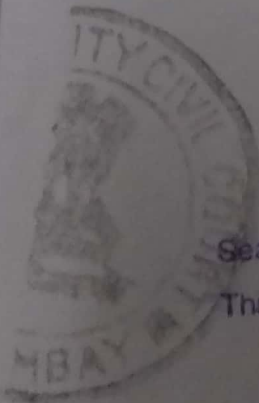
